ASSUMPTION OF RISKS, RELEASE, AND INDEMNIFICATION AGREEMENT

NOTE: BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY!

In consideration for allowing my minor child/ward, _____, to participate in the related events and activities of Zion Hill Camp ("ZHC") of the Wesleyan Church

of Canada ("WCC"), I hereby warrant and agree:

1. I am the parent/guardian having full legal responsibility for decisions regarding my minor child/ward; and

2. I am familiar with and accept, on behalf of myself and my minor child/ward, that there is the risk of serious injury and death to passage in a motor vehicle, including but not limited to:

a. a chartered bus, owned and operated by a commercial transportation company;

b. a privately-owned vehicle, driven in accordance with ZHC policy on Volunteer Drivers and Privately-owned Vehicles;

3. I understand, and will instruct my minor child/ward, that all applicable rules for participation must be followed.

I, on behalf of my minor child/ward, his/her heirs, assigns, executors, successors, and administrators do hereby:

a) waive any and all claims or causes of action whether in contract or tort (including negligence) that I have or may have in the future against WCC and ZHC as a result of involvement in their events by my minor child/ward.

b) release WCC and ZHC from any and all liability for any loss, damage, cause of action, injury or expense that my minor child/ward may suffer as a result of involvement in their events; and

c) agree to save harmless and indemnify WCC and ZHC from any loss, damage, causes of action, injury or expense to any third party as a result of involvement in their events by my minor child/ward.
